#### Justification:

Acting upon the conclusions reached within the evaluation of fulfilment of conditions for participation in the tender, the commission was supposed to assess the bids in line with the rules for evaluating bids stipulated in Cl. IV. of the tendering documents. The bids received were to be evaluated according to economic advantageousness, using the criterion of **the lowest bid price**.

The decisive factor in the evaluation procedure was the total bid price excl. VAT.

Since the contracting authority received one bid only, i.e. from bidder **DISENO IDEA LIMITED**, the commission did not perform the evaluation procedure, merely stating that the bid received from the above bidder fulfils the contracting authority's requirements and is therefore acceptable, and the commission recommended that the contracting authority decide to select this bid.

The contracting authority agreed to the opinion of the commission, and made the decision as delineated above.

In conformity with Cl. XV. of the tendering documents, the contracting authority reserves the right to disclose a notification of selecting the most suitable bid on the contracting authority's profile. In such case, notifications are understood as delivered to all bidders in the tender at the moment of disclosure.

Advice: A remedy against this decision is not admissible according to the Rules for Supplier Selection in the Operational Programme Entrepreneurship and Competitiveness of Small and Medium Enterprises.
